Final Design Completed on the Water Tower Project

On April 24th our engineers at Parametrix completed the final design and contract documents for the Water Tower Project. Contract documents will be reviewed by CRRWC staff and our attorney before the final design and contract documents go to the USDA for final approval on May 4th. Currently the project is scheduled to be advertised for bid on June 4th with bid closing on July 1st. Construction is scheduled to start in August of this year.

This new system is expected to be in service by October of 2016 and project completion by December of 2016.

Once the project has been awarded and a start date has been finalized we will hold a information meeting with our members that are in the construction area. This meeting will be open to everyone but will pertain to construction only.
