#### New rates go into affect May 23rd

On March 2nd the PUC Commission approved the companies request for a 29.11% increase to cover the cost of the USDA annual loan payment for the Water Tower Project and other expenses that have increased over time. The annual loan payment will be \$193,629. Crooked River Ranch Water Company currently serves 1505 members. This means that \$10.72 of each members increase will go to support the annual loan payment to the USDA.

The new Base Rate will be going from \$23.00 per month to \$34.59 per month with no water usage included. The usage rate will go from \$.83 per 100 Cubic Feet and \$.93 after 6000 Cubic Feet to a flat \$1.09 per 100 Cubic Feet with no tier rate. We have provided a chart so that you can see where your bill may fall with the new rate structure.

The entire list of Tariffs will be available in our office or on the website in middle of May, as soon as they have been made available to us.
