## How we are preparing for the eclipse.

The solar eclipse is only 25 days away! With the expected high volume of people coming to the area viewing this spectacular event, the water company has prepared for emergency situations that may occur, such as power outages etc. We have made sure parts are on hand for most of our common repairs and have filled the generator at well #5 in case of any power outages. Arrangements have been made for extra fuel in the case of an extended power outage. We do ask that everyone please try to conserve water if we do happen to have an extended power outage. The Crooked River Ranch Water Co staff will be on call 24 hours starting the weekend before the eclipse. This will allow for quick response for any emergency needs.

Our office will be closed on August 21st the day of the eclipse. With the large amount of people expected in the area, we feel it is important that we do not open the office and allow our staff to stay home. Once again staff will be available for any emergency situations.

## 2018 begins the next phase of our backflow prevention program.

Starting in the spring of 2018, we will require properties without backflow prevention assembly to have CRRWC install one at the owners expense. We require that every property have a backflow assembly at the street to prevent any potential contamination. These assemblies must be installed by our staff as part of a 2013 rule with the PUC (Public Utilities Commission).

We are encouraging anyone that would like to get ahead of the program and have theirs installed this year to contact our office. You may make a one time payment or sign up for the 12 month interest free payment plan.
