The Health of Your Water System

In our February Newsletter we talked about chlorinating the water system again as a safety precaution. This was the result of a positive coliform sample that we received in January. After the OHA (Oregon Health Authority) reviewed the cause of the contamination and what was done to correct the issue, it was determined that all necessary steps were taken and requested that we not perform any type of temporary chlorination. At this time we have suspended any chlorination efforts indefinitely unless directed by the OHA (Oregon Health Authority).

We are committed to providing safe, healthy, and chemical free water to our members now and in the future. We will continue to do everything possible within the limits of the OHA and Oregon Rules to provide the outstanding water you expect.
